Dear Scott Schafer:

Enclosed is your Modified National Pollutant Discharge Elimination System (NPDES) Waste Discharge Permit No. WA0024023. This Modified NPDES Permit satisfies the requirements of both federal and state laws.

The modified permit is identical to the original permit, with the exception of Special Condition S6.A. Pretreatment, which requires the implementation of the modified City of Yakima Industrial Pretreatment Program. Please have your staff replace the original permit with this revised permit.

The modifications include the following:

- Replacing Special Condition S6.A. (pages 27-31)
- Correcting address for Ecology Central Region Office
- Changing Ecology signer to David B. Bowen
- Entire permit repaginated.

The modification does not affect the stringency of the permit and therefore does not require public notice.

Appeal Process

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.


