Please find enclosed Public Utility District No. 1 of Chelan County's (Chelan PUD) National Pollutant Discharge Elimination System (NPDES) Permit applications for Rocky Reach Dam and Rock Island Dam. Rocky Reach Dam is part of the Rocky Reach Hydroelectric Project, which is licensed by the Federal Energy Regulatory Commission (FERC) as Project No. 2145. Rock Island Dam is part of the Rock Island Hydroelectric Project, which is licensed by FERC as Project No. 943.

As directed by Ecology, the applications for Rock Island and Rocky Reach included in this submittal contain:

- Application Form 2C Existing Manufacturing, Commercial, Mining, and Silvicultural;
