

WASTEWATER DISCHARGE PERMIT**

**APPLICANT:** Foss Maritime Company

Seattle, King County

Foss Maritime Company has reapplied for a National Pollutant Discharge Elimination System (NPDES) permit in accordance with the provisions of Chapter 90.48 Revised Code of Washington (RCW), Chapter 173-220 Washington Administrative Code (WAC), and the Federal Clean Water Act. The treated discharge water must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations. The Department of Ecology has developed a draft permit to allow the discharge of drydock floodwater into the Lake Washington Ship Canal.

A tentative determination has been made on the effluent limitations and special permit conditions that will prevent and control pollution. Ecology will make a final determination after evaluating all timely comments received in response to this notice.
