

**NOTICE: ANNOUNCEMENT OF AVAILABILITY OF APPLICATION**  
**PERMIT NO.: ST0501333**  
**APPLICANT: BCSCBN, Inc.**  
**FACILITY: Vantage Bay Water Reclamation Facility**

BCSCBN, Inc. has applied for a new State Waste Discharge Permit No. ST0501333 in accordance with the provisions of Chapter 90.48 Revised Code of Washington (RCW), Chapter 173-216 Washington Administrative Code (WAC), and the Federal Water Pollution Control Act as amended.

Following evaluation of the application and other available information, a draft permit will be developed which would allow the discharge of treated wastewater effluent to a maximum of 113,600 gallons per day (gpd) to a proposed rapid infiltration drainfield located at Latitude 46.9333, Longitude 119.9887, Kittitas County (Vantage). All discharges to be in compliance with the Department of Ecology's Water Quality Standards for a permit to be issued.

The Department of Ecology has determined that it will take no further action on this application at this time. The application and all attachments, submitted January 14, 2021 and accepted January 28, 2021, will become a "temporary permit" effective 30 days following the final date of this notice. Operation consistent with the application and attachments shall be authorized for a period up to 5 years or until Ecology issues a formal permit. A final determination will not be made until all timely comments received in response to this notice have been evaluated.

Interested persons are invited to submit written comments regarding the proposed permit. All comments must be submitted by March 23, 2021 to be considered for the final determination.

Any interested party may request a public hearing on the proposed permit within 30 days of the publication date of this notice. The request for a hearing shall state the interest of the party and the reasons why a hearing is necessary. The request should be sent to the above address. Ecology will hold a hearing if it determines that there is significant public interest. If a hearing is to be held, public notice will be published at least 30 days in advance of the hearing date. Any party responding to this notice with comments will be mailed a copy of a hearing public notice.
