Dear Katherine Cruz:

Thank you for submitting an application for a new SWD permit. The Department of Ecology (Ecology) received the application on April 27, 2022 and has accepted it as complete.

Before Ecology can begin the application process and begin drafting the permit, we are required to collect a one-time permit application fee for new dischargers. Enclosed is an application fee invoice. The fee to complete the processing of your permit application is **\$250**. After you receive a final permit, your annual permit fee will be **\$984**. The permit fee system funds Ecology's permit program based on expenses incurred for the issuance and comprehensive administration of the permits.

Once we receive your application fee, we will publish a legal notice in the local newspaper of record that announces your application and required 30-day comment period. As Ecology drafts the permit, your permit manager may contact you with questions or request a visit to your facility.
