WA0045586 – Lehigh Cement Company

Dear Gregory Ronczka:

The Department of Ecology (Ecology) received a letter dated December 23, 2022 requesting to change the facility name for NPDES permit WA0045586 from Lehigh Cement Company, LLC to Heidelberg Materials. A transfer form was also received February 22, 2023, a copy of the letter and the form are included at the end of this letter.

The form, when completed and signed by both the old and new parties, and approved by Ecology, automatically transfers the permit to the new owner/operator. By signing the form, the new owner/operator agrees to assume all responsibility, coverage, and liability of the permit as of the effective date of the sale or lease. Ecology accepted the form on February 22, 2023 with the permit transfer effective January 1, 2023.

Ecology is unable to change the business name on the permit because the permit is currently expired and has been administratively extended; the name will officially change when a renewal permit is issued.

As a reminder, General Condition G4 of the NPDES permit requires you to give notice to Ecology, as soon as possible, but no later than 180 days prior to any proposed physical alterations or additions to the permitted facility, production increases, or process modification which will result in: 1) the permitted facility being determined to be a new source pursuant to 40 CFR 122.29(b); 2) a significant change in the nature or an increase in quantity of pollutants discharged; or 3) a significant change in the Permittee's sludge use or disposal practices.


