Ecology received documents in compliance with the operations and maintenance (O&M) manual for Artisan Finishing Systems, Inc. (Artisan Finishing) wastewater pretreatment system via email on October 31, 2022. Following Ecology review and comments, Artisan Finishing provided updated documents satisfying the O&M manual requirement on February 28, 2023. The documents submitted include:

- “Artisan Finishing Systems – Pretreatment Operations & Maintenance Procedure – December 2022”. Rev E, Released Feb 2023
- “Wastewater Management Process – Tanks 3&5 – October 2022”
- “Wastewater Management Process – Tanks 8&9 – October 2022”
- “Pre-Treat Press Procedures – Feb 2023”
- “Pretreatment Tank Liner Replacement Procedure – Created July 3 2022”
- “Sludge & Solid Waste Removal Procedure – Tanks 1&2 – July 2022”
- “Water Usage Tracker” examples October 2022 and January 2023

Together, the submitted documents meet the intent of the O&M manual requirement in WAC 173-240-150. The documents provide instructions to employees on operation and maintenance of systems that produce and treat wastewater prior to discharge to the City of Marysville sanitary sewer system.
