NPDES Wastewater Discharge Permit WA0045217 is due to expire on November 30, 2024. Federal law and regulation requires an application for renewal of this permit. To allow Ecology sufficient time to develop the renewal permit, a completed application must be received by our office **on or before November 30, 2023**. It is Ecology's policy to send a permit renewal application form as a reminder to help insure a timely submittal.

PERMIT FEES

Fees paid by permit holders support the wastewater permit program (RCW 90.48.465). Ecology regulation Chapter 173-224 WAC establishes annual permit fees to recover costs associated with issuing and managing wastewater discharge permits. Ecology will continue to collect annual permit fees unless the permit is formally cancelled. Please call 1-800-633-6193 option 2 with questions about permit fees.
