The Ecology Northwest Regional Office recently modified the state waste discharge permit for this facility. This modification changes the permit fee subcategory assessment previously used to determine the FY2001 permit fee.

The Ecology Northwest Regional Office recently issued a new wastewater permit for this facility which has resulted in a change to the permit fee subcategory for State Fiscal Year 1999. The effective date of this change is July 1, 1998.

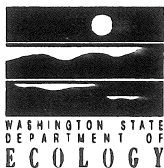
