Re: Termination of Individual National Pollutant Discharge Elimination System Permit (WA0039021), TroutCo Clear Creek Hatchery

Dear Claudio Cerda:

The Washington State Department of Ecology (Ecology) issued permit coverage for TroutCo Clear Creek Hatchery under the Uplands Finfish Hatching and Rearing General Permit on June 12, 2023, which will be effective on August 1, 2023. Coverage for TroutCo Clear Creek Hatchery under this general permit has the permit number WAG994644.

Starting August 1, 2023, the individual NPDES permit (WA0039021) will be placed in inactive status. Do not report under the individual permit number. Please begin monitoring and reporting in accordance with the general permit (WAG994644) and Companion Order #21776. Reporting should be uploaded onto WQ WebPortal under the general permit number.

Your individual NPDES Permit (WA0039021) will be terminated 30 days from the date of this letter in accordance with the provisions [Revised Code of Washington \(RCW\) 90.48.190](#) and the [Washington Administrative Code \(WAC\) 173-220-190](#).

Appeal Process

You have the right to appeal this permit termination within 30 days upon receipt of this document. Pursuant to [Chapter 43.21B RCW](#), your appeal must be filed with the Pollution Control Hearings Board, and served on Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this decision, your notice of appeal must contain:

- A copy of the permit you are appealing; and
- A copy of the termination for the permit.

Any appeal must contain the following in accordance with the rules of the Hearings Board:

- A. The appellant's name and address;
- B. The coverage date and number of the permit appealed;

- C. A description of the substance within the permit that is the subject of the appeal;
- D. A clear, separate, and concise statement of every error alleged to have been committed;
- E. A clear and concise statement of the facts which the requester relies on to sustain his or her statements of error; and
- F. A statement setting forth the relief sought.
