International Raw Materials, Ltd. has applied for a modification of State Waste Discharge Permit in accordance with the provisions of [Chapter 90.48 Revised Code of Washington \(RCW\)](#) and [Chapter 173-216 Washington Administrative Code \(WAC\)](#).

Following evaluation of the request for modification and other available information, a draft permit has been developed which would allow the discharge of treated industrial wastewater from Port of Longview Berths 1 & 2 to Three Rivers Regional Wastewater Treatment Plant.

A tentative determination has been made on the effluent limitations and special permit conditions that will prevent and control pollution. A final determination will not be made until all timely comments received in response to this notice have been evaluated.

Any interested party may request a public hearing on the proposed permit modification within 30 days of the publication date of this notice. The request for a hearing shall state the interest of the party and the reasons why a hearing is necessary. The request should be sent to the above address. Ecology will hold a hearing if it determines that there is significant public interest. If a hearing is to be held, a public notice will be published at least 30 days in advance of the hearing date. Any party responding to this notice with comments will be mailed a copy of a hearing public notice.
