Re: Permit Modification for State Waste Discharge Permit Number ST 6263, Port of Longview Berths 1 & 2 - IRM, Permit Modification

Dear Maribel Rodriguez:

The State Waste Discharge Permit that was issued for your facility on July 28, 2021, is hereby modified for the following particulars:

- Maximum daily effluent limit (flow) will be decreased from 50,000 gallons per day (gpd) to 22,000 gpd with an average monthly effluent limit of 10,000 gpd.

The enclosed permit is your official copy of the permit modification.

Appeal Process

You have the right to appeal this permit modification within 30 days upon receipt of this document. You are not able to appeal the entire permit. Pursuant to [Chapter 43.21B RCW](#), your appeal must be filed with the Pollution Control Hearings Board, and served on Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this decision, your notice of appeal must contain:

- A copy of the permit you are appealing; and
- A copy of the application for the permit/modification.

Any appeal must contain the following in accordance with the rules of the Hearings Board:

- A. The appellant's name and address;
- B. The coverage date and number of the permit appealed;
- C. A description of the substance within the permit that is the subject of the appeal;
- D. A clear, separate, and concise statement of every error alleged to have been committed;
- E. A clear and concise statement of the facts which the requester relies to sustain his or her statements of error; and
- F. A statement setting forth the relief sought.
