

Addendum to the Fact Sheet for State Waste Discharge to POTW Discharge Permit No. ST0006167

Public Notice of Modification Date: June __, 2024

1. General Information

This is an addendum to the fact sheet to explain changes proposed for State Waste Discharge to POTW Permit No. ST0006167, issued on July 14, 2021. Weyerhaeuser Raymond Lumber Mill requests an increase in their Daily Maximum flow to 50,000 gpd from 20,000 gpd and Average Monthly flow to 70,000 gpd from 40,000 gpd. Ecology is modifying the permit to accommodate the facility's request.

Note: New text in the modified permit is marked with grey highlight.

2. Modification to the Permit

Page 5, S1. Discharge Limits: Effluent Limits: Outfall 003 table. Average Monthly flow changed from 40,000 gpd to 70,000 gpd and Daily Maximum flow changed from 20,000 gpd to 50,000 gpd.

3. Justification

On April 24, 2024, Ecology received a letter, prepared by Angela Cameron on behalf of the Permittee, requesting an increase in Daily Maximum and Average Monthly flow. The City of Raymond signed Section J of the SWD to POTW permit application approving the request. The increase of flow should not result in an upset to the City's POTW.

Weyerhaeuser Raymond Lumber Mill will be replacing their current batch kiln system with a continuous dry kiln system for drying lumber. This change will lead to an increase in condensate generated and discharged to Willapa Regional Wastewater Treatment Plant. The current batch kilns and boiler systems will be removed and no longer contribute to wastewater discharged. Weyerhaeuser Raymond plans to install aeration vaults or ponds to ensure proper pretreatment of wastewater to meet their current

permit requirements for pH, BOD, and TSS before discharging to Willapa Regional Wastewater Treatment Plant.

Therefore, as authorized under WAC 173-220-190, Ecology agreed to modify the permit to increase the daily maximum and monthly average flow.

4. Public Process

The proposed changes made in this modification are considered to constitute a major modification under WAC 173-220-190 and are required to be published for a 30-day public review and comment period.

Appendix A - Public Involvement Information

The proposed changes to this permit constitute a major modification under 40 CFR 122.62. Notice of the draft permit modification will be published to allow a 30-day public review and comment period. This modification will be published in the Willapa Harbor Herald on June 12, 2024, to fulfil the above requirements. The issuance of the final modification is contingent upon the outcome of the public review and comment period.

Appendix B - Your Right to Appeal

You have a right to appeal this permit to the Pollution Control Hearing Board (PCHB) within 30 days of the date of receipt of the final permit. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2) (see glossary).

To appeal you must do the following within 30 days of the date of receipt of this permit:

- File your appeal and a copy of this permit with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours as defined in WAC 371-08-305 and -335. "Notice of appeal" is defined in WAC 371-08-340.
- Serve a copy of your appeal and this permit on Ecology on the Department of Ecology mail, in person, or by email (see addresses below).
- You must also comply with other applicable requirements in Chapter 43.21B RCW and Chapter 371-08 WAC.
