Dear Gary Price:

Your National Pollutant Discharge Elimination System (NPDES) Wastewater Discharge Permit No. WA0002437 is enclosed. This NPDES Permit satisfies the requirements of both federal and state laws. The Department of Ecology (Ecology) issues this permit in accordance with Chapter 90.48 RCW, as amended, and the Federal Water Pollution Control Act, as amended.

Discharge Monitoring Reports (DMRs) Electronic Reporting

Your new permit requires you to submit regularly scheduled Discharge Monitoring Reports (DMRs) by using WQWebDMR which is Ecology's electronic data reporting system. Please feel free to contact Ecology if you have any questions about WQWebDMR.

If you are unable to submit your DMR electronically, contact the Water Quality Permit Coordinator, Department of Ecology, 1250 West Alder Street, Union Gap, WA 98903-0009, to request a waiver to use WQWebDMR and obtain a paper DMR form.

Appeal Process

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this action or decision, your notice of appeal must contain:

- (1) A copy of the permit you are appealing, and
- (2) A copy of the application for the permit.
