**Post Point Pollution Control Plant

**Summary of Level One Responce and Remedial Actions**

Staff at the City of Bellingham Post Point Pollution Control Plant (City) conducted regular quarterly stormwater monitoring on December 13, 2007. The rain event began at 07:45 and ended at 24:00. Total rainfall of 0.39 inches was recorded over this time. Samples were collected between 08:25 and 09:05 from all 3 designated sampling sites at our facility and were immediately analyzed for turbidity and pH at the City's accredited lab. Zinc and copper samples were sent to Edge Analytical for analysis.

The turbidity of stormwater collected from discharge site A was measured as 26.4 NTU and was therefore above the benchmark value of 25 NTU. Upon visual inspection, an abnormal amount of dirt and gravel was found adjacent to the discharge site. Site A is located in the center of a roadway on the facility grounds. The accumulation of this dirt is from a large scale construction project on site and the resultant truck traffic from nearby on-site construction in the months prior to sampling. The facility manager was notified and indicated that the impervious surface surrounding site A would be swept.
