**RE: Time to Reapply for the Industrial Stormwater General Permit (ISGP)**

Dear David Butcher:

On April 30, 2014, Ecology mailed a letter reminding all Industrial Stormwater General Permit (ISGP) holders that it is time to reapply. The deadline of July 5, 2014 has passed. You are receiving this letter because you have either not reapplied, or you have not completed the reapplication process. If you are the responsible official, you can complete the electronic application process in two different ways. You may choose to obtain Ecology approval for an electronic signature account to electronically sign the application, which would also allow you to electronically sign the permit-required discharge monitoring reports (DMRs). If you delegate authority to others to submit DMRs, you may prefer to sign and submit the certification form, which is available to print as you complete the electronic application. Ecology must have either the electronic signature form or the certification form on file – signed by the legally responsible official before it can consider the application complete and renew permit coverage. **If someone other than you is responsible for the reapplication process, please pass this information to that person.**

State and Federal rules require permit holders to reapply for permit coverage at least 180 days prior to the expiration date of the current ISGP, which expires on January 1, 2015.

- **Please submit your online application immediately.**
- In November 2014, Ecology will send you a letter confirming your renewed permit coverage along with a copy of the new ISGP.
- If you fail to reapply for the ISGP, your current permit will be cancelled on January 1, 2015. Discharging stormwater associated with industrial activity without the proper permits may result in enforcement action, including monetary penalties.

Ecology is in the process of updating and reissuing the ISGP. Permit holders and other interested parties had an opportunity to review and submit comments on the draft ISGP from May 7 through June 20, 2014. Ecology will consider all public comments received before issuing the final ISGP in November 2014, with an effective date of January 1, 2015.
