MODIFICATION OF COVERAGE

A Coverage Modification due to Change in Operations form under the Fresh Fruit Packing (the general permit) for the referenced facility was received by the Department of Ecology on May 28, 2015. Based upon the information in this change form it has been determined that your facility is eligible for this modification of coverage under the general permit. This modification includes the following:

- *Add Outfall 003 - Wastewater from Outfall 001 and Outfall 002, with chlorine-based fungicides + NCCW Chemical Additives to Lined Lagoon, Effective June 1, 2015*

Enclosed is a new permit cover sheet reflecting this modification to Wastewater Discharge Permit No. WAG 43-5290. This modification has been done in accordance with the Federal Water Pollution Control Act, as amended, Chapter 90.48 RCW, as amended, and Chapter 173-226 WAC.

A Public Notice of this modification was not needed because there was no substantial increase or change in the volume, characteristics, or Treatment/Disposal Method of the wastewater discharge.


