Dear Jim Tallman:

You are receiving this letter because our records show you have not re-applied for continued CSWGP coverage and your permit coverage expired December 31, 2015. If you plan to terminate your permit, you will find the Notice of Termination (NOT) by following this link: <https://fortress.wa.gov/ecy/publications/SummaryPages/ecy02087.html>.

Please be aware that NOTs are subject to an Ecology inspection and Ecology has up to 30 days to determine eligibility for termination per Special Condition S10 of the CSWGP.

Ecology mailed reminders to renew on April 3, 2015, August 18, 2015, and November 3, 2015. Renewal of the CSWGP will ensure continued permit coverage in 2016. To avoid a lapse in permit coverage and corrective action that may result in a monetary penalty, you are advised to renew your permit coverage immediately.
