Farwest Fabricators, Inc., Effective February 1, 2017**

Dear Mr. Carter:

Enclosed is your State Waste Discharge Permit No. ST0009193 which has been reauthorized in accordance with Chapter 90.48 RCW, as amended, and the Federal Water Pollution Control Act, as amended. This State Permit satisfies the requirements of both federal and state laws. This permit is being reauthorized for a period of up to five years. However, changes in state or federal rules or additional information regarding the impact of the discharges on the receiving waters could cause it to be reopened and modified, as necessary.

Discharge Monitoring Reports (DMRs)

Included is a DMR form for your use in accordance with the conditions stated in the enclosed permit. Your permit requires submittal of monitoring results **semi-annually**, to be received or postmarked no later than **August 15, 2017 and February 15, 2018** and each year thereafter during the permit term.

Appeal Process

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this action or decision, your notice of appeal must contain:

- (1) A copy of the permit you are appealing, and
- (2) A copy of the application for the permit.


