Section D: Summary of Findings/Comments

CONCERNS AND RECOMMENDATIONS

As a result of my inspection I have the following recommendations:

- The uncovered garbage container in the concrete vault should be covered and moved to prevent garbage container leachate from entering the storm drain in the bottom of the vault.
- Equipment and/or materials exposed to the elements should be covered or moved inside, if possible, to limit or prevent pollutants from entering the facility's storm drains.
- Harbor Island Machine Works should begin to collect and submit a stormwater sampling result each quarter as stated in condition S4.A of the Industrial Stormwater General Permit (modification date: December 1, 2004), even if one or more of the permit sample collection criteria can not be met.

BACKGROUND

Harbor Island Machine Works is a custom machine shop which machines metal and refurbishes metal parts for various clients. No vehicle storage, stationary or mobile fueling, washing or maintenance occurs at the facility. The facility's storm water catch basins are cleaned and inspected quarterly.

This facility is covered under the industrial stormwater general permit and has not been inspected previously by the Department of Ecology. The purpose of this inspection is to conduct a compliance inspection per the requirement of the Revised Code of Washington (RCW) 90.48.560 and to provide technical assistance as appropriate.

INSPECTION

This inspection was in collaboration with Surface Water Quality Inspector Savina Uzunow from Seattle Public Utilities.

We arrived at the facility and met Mark DeFaccio representing Harbor Island Machine Works. We explained the purpose of the inspection. I reviewed the facility's Stormwater Pollution Prevention Plan (SWPPP) and I discussed the facility's discharge monitoring reports (DMRs) with Mr. DeFaccio.


I brought to the attention of Mr. DeFaccio that for the last six quarters the facility has only once sampled their storm water discharges. The other five quarters of DMRs submittals indicated that there were no qualifying storm events. He explained it was very difficult to meet the storm event criteria stated in the permit. I informed him that Ecology has received feed back from permittees describing the same problem and for that reason and others the Industrial Stormwater General Permit has been modified effective January 14, 2005.

We then inspected the stormwater catch basins, discharge monitoring sampling site, outside storage area and parking area in front of the facility.
