Dear Mr. Entz:

The Department of Ecology (Ecology) is issuing this Notice of Violation to you for violating provisions of Chapter 90.48 Revised Code of Washington (RCW) Water Pollution Control. This notice contains Ecology's determination that a violation has or will occur.

Ecology has the authority to issue this Notice of Violation under RCW 90.48.120(1) which reads in part:

"Whenever, in the opinion of the department, any person shall violate or creates a substantial potential to violate the provisions of this chapter or chapter 90.56 RCW, or fails to control the polluting content of waste discharged, or to be discharged into any waters of the state, the department shall notify such person of its determination by registered mail."

DETERMINATION OF VIOLATIONS

Notice is hereby given in accordance with RCW 90.48.120(1), as follows:

During the air inspection on August 17, 2017, Cosmo Specialty Fibers (Cosmo) notified Ecology of leaks from their underground process sewer line. This line is constructed of wood stave and conveys treated wastewater to be discharged through outfall 001. The leak is ongoing as of the date of this Notice of Violation and has the potential to discharge to waters of the state, both groundwater and surface water. The leaking pipe is also out of compliance with Cosmo's NPDES permit no. WA0000809 Condition S4 requirement to "at all times, properly operate and maintain all facilities or systems of treatment and control (and related appurtenances)." This determination does not constitute an Order or directive under RCW 43.21B.310.

FILE A REPORT WITH ECOLOGY

Pursuant to RCW 90.48.120(1), within thirty (30) days from receipt of this Notice of Violation Cosmo Specialty Fibers must file a full report with Ecology stating:

1. What steps HAVE BEEN taken to control such waste or pollution to otherwise comply with this determination of Ecology?
2. What steps ARE BEING taken to control such waste or pollution to otherwise comply with this determination of Ecology?
