Dear Mr. Konopasek:

State Waste Discharge permit ST0005335 is due to expire on February 28, 2019 and requires an application for its renewal. To allow Ecology sufficient time to develop Tyson's permit, a completed application must be received by our office **on or before February 28, 2018**. It is Ecology's policy to send a permit renewal application at least one year prior to the expiration date to help insure a timely submittal.

The permit manager requests that you complete the sections marked below as well as any additional sections that may apply if there have been significant changes to the facility or the character of the wastewater have changed. Please submit any additional information that may help Ecology determine the impact of your discharge to groundwater.

Completing the Application

A principal executive officer must sign the application (WAC 173-216-070).

The principal executive officer may delegate signature authority for submittals required by the permit such as monthly reports to a specific, qualified individual or to a position that Ecology expects is filled with a qualified individual. Please submit a copy of the letter delegating signature authority along with the application for our files.

Permit Fees

Ecology regulation (Chapter 173-224 WAC) establishes annual permit fees to recover costs associated with issuing and managing wastewater discharge permits. Ecology will continue to assess and bill annual permit fees unless the permit is formally cancelled. Please call 1-800-633-6193 (option 2) with questions about permit fees.
