The Washington State Department of Ecology (Ecology) has reviewed the application that you submitted on January 5, 2018, for the renewal of state waste discharge permit for Iron Horse Brewery. The application was deemed to be incomplete. The following comments and deficiencies were noted:

1. Section A.5: The UBI# provided (602749537) is different from the previous application (602749538). Please verify which is correct.
2. Section A.6: Lat, long is not represented in decimal degrees. Measured by Google Earth at the Gate to the Facility, we get 47.000141, -120.520906.
3. Section A.8: Application Signatory section is only partially filled out with the word "Brewmaster". Complete or delete.
4. Section B.1: Applicant did not provide the SIC Code 2082 for the facility.
5. Section C.4: Notifications of planned improvements to reduce BOD-5 or TSS will be made in accordance with existing permit conditions.
6. Page 8: Did not fully print and as such, is missing information rendering the application incomplete.
7. Page 9: See Page 8 comments.
8. Page 10: See Page 8 comments.
9. Section F.1: The Yes box was marked on the previous application. Please verify whether this site has an inspection and sampling manhole.
10. Section H.3: The facility should evaluate whether additional boxes should be marked for Manufacturing, Material Handling, and Material Storage.
11. Section H.4.b: The application indicates materials are stored on spill containment pallets. The Spill Prevention box could be marked in this section.

12. Section J.1: Provide the name "Ellensburg Wastewater Plant" and correct the street name to "Canyon".
13. Section J.2: This section is partially filled out without signature. If this section is not applicable, please delete.
