**RE: Issuance of Coverage under the Aquatic Plant and Algae Management General Permit**

Dear Mr. McNabb:

The Washington Department of Ecology (Ecology) received your application for coverage under the Aquatic Plant and Algae Management NPDES and State Waste Discharge General Permit (permit). Ecology is issuing you coverage under the permit as of April 16, 2018. **Retain this letter with your permit documents. It is part of the official record of permit coverage.**

**Coordination with Other Permit Holders**

Lake Jeane is unique because it has more than one permit coverage that applies to the same area of the Lake. To prevent permit violations and violation of pesticide product labels, coordination between permit holders (licensed pesticide applicators) is necessary in this situation. Failure to coordinate with other applicators may result in treatments which are not allowed by the product label, which is also a permit violation. Label and permit violations may result in enforcement actions by Ecology and/or Washington Department of Agriculture.

Ecology's role is to ensure permit compliance. Ecology will not make lake management decisions, arbitrate between parties to determine whether a treatment is appropriate, or determine if a party is following the Lake Jeane Settlement Agreement (*Ward v. Twin Lakes Golf & Country Club*, King County Superior Court No. 16-2-07439-1 SEA, Stipulated Final Judgment and Order (Dec. 18, 2017)).

**Treatment Timing Window**

Ecology is conditioning this permit coverage for some active ingredients to mitigate impacts to salmonids and Washington Department of Fish and Wildlife priority habitats and species using Treatment Timing Windows. Treatment Timing Windows set periods of time during which treatment with specific herbicides is allowed. For this coverage the Treatment Timing Windows are:

Waterbody Treatment Timing Window:	Year around as needed.

#### **Permit Fees**

State law (RCW 90.48.465) requires that all Permittees pay an annual permit fee based upon the state fiscal year. The state fiscal year begins each year on July 1, and ends on June 30 the following year. Ecology mails permit fee bills to all Permittees annually. Permittees that have permit coverage on July 1 will receive a permit fee bill.
