Thank you for submitting an application for a new state waste discharge permit. The Department of Ecology (Ecology) acknowledges receiving the application on June 26, 2018, and an initial review shows that your application does not evaluate all stormwater discharges for pollutants of concern. Please see the inspection report dated March 30, 2016, for details. Nevertheless, Ecology is accepting the application and plans to address deficiencies in the permit. Jacek Anuszewski has been assigned to develop your wastewater permit and he can be reached at 360-407-6288.

Before Ecology can begin the next phase of the permit process, we need to collect a permit application fee. The fee to complete the processing of your permit is \$2348.25, which is 25 percent of your total annual operating fee. Enclosed is a fee remittance form for your convenience.
