

**NOTICE: ANNOUNCEMENT OF AVAILABILITY OF DRAFT RECLAIMED
WATER PERMIT**

has reapplied for a State Waste Discharge permit in accordance with the provisions of Chapter 90.46 Revised Code of Washington (RCW) and Chapter 173-219 Washington Administrative Code (WAC). The wastewater, following treatment, must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations for the permit to be issued.

The Holmes Harbor Sewer District presently operates a sequencing batch reactor with sand filtration secondary treatment plant designed to handle a maximum month flow of 0.1 MGD. The wastewater, following treatment, must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations for a permit to be issued. Following evaluation of the application and other available information, a draft permit has been developed which would allow the discharge of Class A reclaimed water to land via spray irrigation to authorized use locations specified in the permit.

A tentative determination has been made on the effluent limitations and special permit conditions that will prevent and control pollution. A final determination will not be made until all timely comments received in response to this notice have been evaluated.
