The Department of Ecology made the following clarifications and corrected typographical errors to Hecla Limited's State Waste Discharge permit ST0005270:


1. Page 4, Summary of Permit Report Submittals, Section S4.A

The submittal due date for the O&M annual review confirmation letter was entered into the submittal table as December 15, 2019. However, in Section S4.A of the permit, the due date is entered as October 1st of each year. The submittal table has been corrected to match the date in Section S4.A with a submittal due date of October 1, 2018. Additionally, the requirement for an O&M manual submittal during the permit cycle was a typo and was removed, only annual reviews or updates are required by the permit.

The corrected pages are enclosed. Please replace the current pages with the corrected versions. Since it is not a major change, we are correcting the permit and no public comment period is necessary.
