RE: Modification of State Waste Discharge Permit No. ST0006227

Dear Tom Welinski:

The state waste discharge permit that was issued for your facility on March 8, 2017, is hereby modified. The enclosed revised pages of the permit are your official copy of the modification.

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B Revised Code of Washington (RCW), your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology (Ecology), within 30 days of the date of your receipt of this document. You may appeal only the explicit language modified, and not the entire permit.

If you choose to appeal this action or decision, your notice of appeal must contain: 1) A copy of the permit you are appealing, and 2) A copy of the application for the permit.

Any appeal must contain the following in accordance with the rules of the hearing board:

- a. The appellant's name and address;
- b. The coverage date and number of the permit appealed;
- c. A description of the substance within the permit that is the subject of the appeal;
- d. A clear, separate, and concise statement of every error alleged to have been committed;
- e. A clear and concise statement of the facts which the requester relies to sustain his or her statements of error; and
- f. A statement setting forth the relief sought.


