**RE: Issuance of NPDES Waste Discharge Permit No. WA0052175 for the Peshastin Publicly Owned Treatment Works (POTW), Effective June 1, 2019**

Dear Ron Slabaugh:

Your National Pollutant Discharge Elimination System (NPDES) Wastewater Discharge Permit No. WA0052175 is enclosed. This NPDES Permit satisfies the requirements of both federal and state laws. The Department of Ecology issues this permit in accordance with Chapter 90.48 RCW, as amended, and the Federal Water Pollution Control Act, as amended.

**Permit Fees**

The Department of Ecology (Ecology), in response to the passage of Initiative 97 in 1988, has adopted a regulation to recover costs associated with issuing and administering wastewater discharge permits (Chapter 173-224 WAC).

The annual fee for both industrial and municipal/domestic discharges is computed according to the permit fee schedules contained in WAC 173-224-040. We notify permit holders of fee charges by mailed billing statements. Failure to pay the applicable permit fee may result in the suspension or revocation of the permit, and could result in the issuance of civil penalties or actions to enjoin the activity under the permit.

**Appeal Process**

You have the right to appeal this permit within 30 days upon receipt of this document. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this action or decision, your notice of appeal must contain:

- (1) A copy of the permit you are appealing, and
- (2) A copy of the application for the permit.
