

The Department of Ecology (Ecology) is issuing this Notice of Violation to you for violating provisions of Chapter 90.48 Revised Code of Washington (RCW) Water Pollution Control. This notice contains Ecology's determination that a violation has or will occur.

Ecology has the authority to issue this Notice of Violation under RCW 90.48.120(1) which reads in part:

"Whenever, in the opinion of the department, any person shall violate or creates a substantial potential to violate the provisions of this chapter or chapter 90.56 RCW, or fails to control the polluting content of waste discharged, or to be discharged into any waters of the state, the department shall notify such person of its determination by registered mail."

DETERMINATION OF VIOLATIONS

Notice is hereby given in accordance with RCW 90.48.120(1), as follows:

The violation is of Condition S4 of NPDES Permit No. WA0000809, which requires the facility to properly operate and maintain their wastewater treatment system, including the wastewater conveyance systems. The violation relates to leaks from the wood stave line conveying treated effluent to Outfall 001. The line is leaking in at least three, potentially four, sections. The leaks were reported to Ecology on August 8, 2019 and observed during Ecology's site visit on August 13, 2019. The leaks are ongoing as of the date of this Notice of Violation.

This determination does not constitute an Order or directive under RCW 43.21B.310.

FILE A REPORT WITH ECOLOGY

Pursuant to RCW 90.48.120(1), within thirty (30) days from receipt of this Notice of Violation Cosmo Specialty Fibers must file a full report with Ecology stating:

1. What steps HAVE BEEN taken to control such waste or pollution to otherwise comply with this determination of Ecology.
2. What steps ARE BEING taken to control such waste or pollution to otherwise comply with this determination of Ecology.


