Dear Gary Ivory:

Thank you for your May 20, 2019 application for a new NPDES wastewater discharge permit and an initial review shows that your application is complete and accepted on October 23, 2019.

Your application is a matter of public record. State Water Pollution Control Laws requires publishing of a legal Public Notice which describes the discharge for any operation. This is to give the public a chance to be aware of, and comment on any wastewater treatment and disposal facilities. In compliance with this requirement, enclosed is a copy of the Public Notice describing your wastewater discharge. The Department of Ecology will publish this notice in the "Legal Classified Section" of the **Wenatchee World** on **November 8, 2019**. There will be a 30 day comment period from the last publication date.

To begin the next phase of the permit process, Ecology has an application fee of **\$1,981.00**. The fee is calculated based on a minimum of \$250 or 25 percent of your total annual operating fee, whichever is greater.

Once the application fee is received, Ecology will write a draft permit for your review. We anticipate to begin developing your permit immediately.

In response to the passage of Initiative 97, now codified as RCW 90.48.465, Ecology has adopted a regulation (Chapter 173-224 WAC) establishing annual permit fees for all municipal/domestic and industrial wastewater discharge permit holders.
