Re: National Pollutant Discharge Elimination System (NPDES) Permit Issuance for TroutCo Clear Creek Hatchery and Trout Springs Canyon Falls Hatchery

Dear Austin Franklin:

Enclosed are NPDES Permit Numbers WA0039021 and WA0039268. The permits are issued by the Department of Ecology (Ecology) in conformance with the Water Pollution Control Law [Chapter 90.48 Revised Code of Washington (RCW)], and as authorized by the U.S. Environmental Protection Agency (EPA) acting under the Federal Clean Water Act.

These permits require that you submit monthly discharge monitoring reports (DMRs), every quarter, electronically using Ecology's secure online system, WQWebDMR. To sign up for WQWebDMR go to: www.ecy.wa.gov/programs/wq/permits/paris/webdmr.html. If you have questions, contact the portal staff at (360) 407-7097 (Olympia area), or (800) 633-6193/option 3, or email WQWebPortal@ecy.wa.gov. If no discharge occurs during a reporting period, you must still submit a DMR with a statement that no discharge occurred.

Submission of an application for permit renewal or continued discharge must be received by Ecology no later than **April 30, 2023** [Washington Administrative Code (WAC) 173-220-180]. Permit Fees

Ecology, in response to the passage of Initiative 97 in 1988, has adopted a regulation to recover costs associated with the issuance and administration of wastewater discharge permits (Chapter 173-220 WAC).

The annual fee for both industrial and municipal/domestic discharges is computed according to the permit fee schedules contained in WAC 173-224-040. Ecology notifies permit holders of fee changes by mailed billing statements. Failure to pay the applicable permit fee may result in the suspension or revocation of the permit, and could result in the issuance of civil penalties or actions to enjoin the activity under the permit.



Appeal Process

You have the right to appeal these permits within 30 days upon receipt of this document. Pursuant to Chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within 30 days of the date of your receipt of this document.

If you choose to appeal this decision, your notice of appeal must contain: (1) a copy of the permit you are appealing, and (2) a copy of the application for the permit/modification.

Any appeal must contain the following in accordance with the rules of the Hearings Board:

- a. The appellant's name and address;
- b. The coverage date and number of the permit appealed;
- c. A description of the substance within the permit that is the subject of the appeal;
- d. A clear, separate, and concise statement of every error alleged to have been committed;
- e. A clear and concise statement of the facts which the requester relies to sustain his or her statements of error; and
- f. A statement setting forth the relief sought.


