Dear Annie Herrold:

The Washington Department of Ecology (Ecology) received your renewal application for coverage under the *Zostera japonica* Management on Commercial Clam Beds in Willapa Bay General Permit (*Z. japonica* permit). Ecology is reissuing your coverage under the *Z. japonica* permit beginning April 4, 2020, the effective date of the *Z. japonica* permit. Your coverage applies to the commercial clam beds listed on the attached Permit Coverage Summary Table. **Retain this letter with your permit. It is part of the official record of permit coverage for your operations.**

Permit Fees: State law (RCW 90.48.465) requires that all permittees pay an annual permit fee based upon the state fiscal year. The state fiscal year begins each year on July 1st, and ends on June 30th the following year. Ecology mails permit fee bills to all permittees annually. Permittees that have permit coverage on July 1st will receive a permit fee bill.
