Chapter 173-220 of the Washington Administrative Code (WAC) requires a Permittee to file an application for replacement.

Your NPDES Waste Discharge Permit No. WA0041084 **expired** on January 31, 2019. We are, therefore, enclosing a new waste discharge permit application. Your permit application is a matter of public record. When the Department of Ecology (Ecology) decides to proceed with re-issuance of your permit, a public notice of application will be issued to a newspaper of local circulation. This will allow the public to comment on Ecology's decision regarding your permit.

NPDES regulations require the submission of sludge information with the re-application for an NPDES permit. The following information is required to determine if additional pretreatment measures are required:

1. The most recent five years of sludge monitoring data for pollutants listed in 40 Code of Federal Regulations (CFR) 503.13 tables 1 and 3.
2. The quality necessary to meet the chosen use and disposal procedures at the facility (i.e., which tables; 1 or 3 of 40 CFR 503.13 are applicable).
