Notice of Termination (NOT) for National Pollutant Discharge Elimination System (NPDES) Industrial Stormwater General Permit (ISGP) authorization WAR001693 was received by Department of Ecology (Ecology) on August 6, 2020. The purpose of this inspection was to determine whether the site was eligible to terminate ISGP coverage.

The NOT states that all outdoor operational activity has ceased and office space has been rented back from owner. Inspection of the facility confirmed that outdoor operations have ceased and industrial equipment and materials were not present.

The request to terminate ISGP authorization WAR001693 is approved.

Appeal of this Action

You have a right to appeal this action. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. “Date of receipt” is defined in RCW 43.21B.001 (2).

- To appeal, you must do the following within 30 days of the date of receipt of this letter: File your appeal and a copy of the permit cover page with the Pollution Control Hearings Board (PCHB) (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and the permit cover page on Ecology in paper form - by mail or in person (see addresses below). E-mail is not accepted.

You must also comply with other applicable requirements in chapter 43.21B RCW and chapter 371-08 WAC.
