Hello Marcia-

Just providing an update on the upcoming plans to repeat the Trinity pilot study we conducted last winter. If you recall, we did a very small number of fish in 2019/2020 of around 300 and Ecology's determination was to be di-minimus and not needing analysis. The first season went very well and better than expected in some regards considering the nature of the site location. We'd like to proceed with Yr. 2 of the pilot with the only requested alternation being an increase in fish production to mirror densities that could be closer to future, full operations scenarios. This would require closer to 900 fish and at a starting weight of 25fpp; approximately 36lbs starting weight. In comparison, full on-site production after build-out would be closer to 5,000 starting pounds.

Please let me know if this is good to move forward with. Tentatively fish transport would be last week of October with feed beginning Nov. 1.
