

# Bellingham man suspected of inappropriately touching woman

A Bellingham man is suspected of holding a woman he knew on a bed, putting his hands over her mouth so she couldn't scream and touching her inappropriately during a Roosevelt neighborhood domestic dispute Friday afternoon.

Bellingham police booked Oswaldo Jose Gonzalez-Jimenez into Whatcom County Jail on July 17 on suspicion of unlawful imprisonment (domestic violence), in-

decent liberties (domestic violence) and fourth-degree assault (domestic violence). Jail records show he is being held in lieu of \$100,000 bail.

Officers were called at 4:26 p.m. to the 2100 block of Alabama Street for the report of a physical domestic incident, according to information provided to The Bellingham Herald in an email from Lt. Claudia Murphy.

Officers found that Gonzalez-Jimenez and the victim got into an argument in a bedroom because Gonzalez-Jimenez wanted to engage in sex-

ual activity and the victim did not, Murphy reported. The victim attempted to leave the room, and that allegedly prompted Gonzalez-Jimenez to get angry and prevent her from leaving by grabbing her wrist, wrapping her up and putting her on the bed.

When the victim objected, Gonzalez-Jimenez put his hand over her mouth to prevent her from screaming, but also making it difficult for her to breathe, Murphy wrote.

While still holding her down, Gonzalez-Jimenez then started touching the victim's intimate areas against her will, according to Murphy.

The victim was able to get away and get family members to call 911 for help, Murphy reported, and Gonzalez-Jimenez admitted to officers that he prevented her from leaving the bedroom and put his hands over her

mouth to stop her from speaking.

## Homeless man allegedly used club in robbery

Bellingham police arrested a transient man Tuesday they suspect hit another person three or four times with a bat or club during a robbery last week at the Lighthouse Mission Ministries Drop-In Center at Bellingham High School.

Phillip Bryan Woody, 56, was booked into Whatcom County Jail July 21 on suspicion of first-degree robbery and jail records show he is being held in lieu of \$50,000 bail.

At approximately 5:22 p.m. on Thursday, July 16, officers were called to Bellingham High for the report of a robbery at the Drop-In Center, Lt. Claudia Murphy told The Bellingham Herald in an email.

The investigation determined that Woody used a club or bat to strike the victim in the torso before stealing a bag, Murphy reported.

The victim, who was taken to the emergency department at St. Joseph hospital for evaluation, was able to give a good description, allowing officers to identify the attacker as Woody, according to Murphy.

The health department and unified command will continue to explore alternative community testing approaches that will provide efficient testing with reduced wait times, easier access for county residents outside Bellingham and accommodations for those who do not have access to a vehicle.

Approximately 1% of those who were tested over the four days were positive for coronavirus, the health department reported earlier this week, which is well below the county's overall average of 2.9% positive results.

Only 7.7% of those tested came from outside Whatcom County, while 86% reported they had health insurance and 33.5% said they had a healthcare provider, according to the earlier health department release. Meanwhile, 11.3% of those tested said they were in close contact with a confirmed coronavirus case and 23.7% reported they had symptoms associated with COVID-19 but had not been in close contact with a confirmed case.

Wednesday. Tuesday those totals were 48,575 cases and 1,465 deaths.

Wiesman said we need to see "rates coming way down," and that: "Decisions haven't been made yet, but I think if you care-

fully look at the data you can probably draw those conclusions that holding at the moment and again considering how we continue to reduce risky interactions needs to be our focus right now."

He has returned pending applications counties had submitted to advance phases before the pause started. They'll be four

weeks old at the end of the month, he said, and will need to be updated when the pause is lifted.

State Health Officer Dr. Kathy Lofy shared a graphic at the briefing that showed the highest rates were in people 80 and older in April, and that at the end of June and in July the highest rates of illness were in people ages 20

24. "One thing that we're really concerned about here in Washington is whether our current trajectory is putting us on the same path that Florida was on," she said. "... That would mean over the next few weeks we would start to see cases in a much broader age group."

# ELECTION

Delay the Election until people can properly, securely and safely vote???"

In fact, only five states conduct elections entirely by mail, although more states expect to rely more heavily on mail-in ballots in November because of the virus outbreak. California has announced plans to send ballots to all registered voters for the fall election, but will also have in-person voting options available.

Trump's tweet came just minutes after the government reported that the U.S. economy shrank at a dizzying 32.9% annual rate in the April-June quarter, by far the worst quarterly plunge ever, as the coronavirus outbreak shut down businesses, threw tens of millions out of

work and sent unemployment surging to 14.7%.

With just over three months until Election Day, Trump trails in the polls nationally and across battleground states.

Trump has increasingly sought to cast doubt on November's election and the expected pandemic-induced surge in mail-in and absentee voting. He has called remote voting options the "biggest risk" to his reelection. His campaign and the Republican Party have sued to combat the practice, which was once a significant advantage for the GOP.

There is no evidence of widespread voter fraud through mail-in voting, and the states that use it exclusively say they have necessary safeguards in

place to ensure that a hostile foreign actor doesn't disrupt the vote. Election security experts say that all forms of voter fraud are rare, including absentee balloting.

Most states are still finalizing their plans for November. A small number of states sent ballots to voters during the primaries, but most states are not expected to do so in November. Instead, voters will have to request an

absentee ballot if they want to vote at home.

Voters and public health officials have expressed concerns about the potential dangers of spreading the virus during in-person voting, and states have reported difficulty filling poll worker positions given the pandemic.

Republican Sen. Marco Rubio of Florida said the election will take place as planned, "be legitimate and ... people should have confidence in it."

Democratic House Speaker Nancy Pelosi replied to Trump's tweet by tweeting a quote from the Constitution assigning Congress the power to set the timing of elections.

One Republican governor, Chris Sununu of New Hampshire, also quickly shot down Trump's idea: "Make no mistake: the election will happen in New Hampshire on November 3rd. End of story.

Our voting system in NH is secure, safe, and reliable. We have done it right 100% of the time for 100 years — this year will be no different."

Hogan Gidley, the Trump campaign's national press secretary, pointed to the delays in counting votes in New York's primary. "The President is just raising a question about the chaos Democrats have created with their insistence on all mail-in voting. They are using coronavirus as their means to try to institute universal mail-in voting, which means sending every registered voter a ballot whether they asked for one or not."

Trump refused in an interview just weeks ago with Fox News to commit to accept the results of the upcoming White House election, recalling a similar threat he made weeks before the 2016 vote.

"I have to see. Look ... I have to see," Trump told moderator Chris Wallace during a wide-ranging interview on "Fox News Sunday." "No, I'm not going to just say 'yes.' I'm not going to say 'no,' and I didn't last time, either." Last month, he also said in Arizona, "This will be, in my opinion, the most corrupt election in the history of our country."

Trump and many members of his administration have previously availed themselves of absentee voting, but Trump has sought to differentiate that from a growing push by states to mail all registered voters either ballots or absentee request forms.

"He has absolutely no power to do this," said Wendy Weiser, director of the democracy program at the Brennan Center for Justice at NYU's Law School. "This is just sowing chaos."
