Your application for a State Waste Discharge (SWD) permit renewal was received by this office on September 24, 2020 and accepted as complete on November 24, 2020.

Your current SWD permit has an expiration date of February 28, 2021. Renewal of the permit is in process; however, the permit may not be issued by the expiration date. In accordance with the Washington State Administrative Procedures Act (RCW 34.05.422(3)) and Washington Administrative Code 173-216-070, if your renewal permit is not issued and effective by the current permit's expiration date, the current permit and its terms and conditions and any changes requested in the permit application, will remain in effect and enforceable until Ecology issues a new permit for your facility.

State law requires the circulation and publication of notices which describe the proposed issuance of SWD permits. This is intended to allow the public to be aware of and comment on such actions. Attached is a copy of the public notice that will be published in the Everett Herald on December 1 and 8, 2020. A similar notice will be mailed from this office to agencies, groups and individuals that have requested such notices for this geographic area. Another public notice will be published when the draft permit has been prepared.
