RE: Reapply for Your Sand and Gravel General Permit Coverage-Final Notice

Dear John Stotts:

The reapplication deadline for the Sand and Gravel General Permit was **October 2, 2020**. **If you have already submitted your renewal application, thank you. Please disregard this additional notice.** Your coverage under the Sand and Gravel General Permit (permit) requires you to reapply for permit coverage at least 180 days prior to the expiration date of your current permit. (General Condition G20)

If you fail to reapply for the Sand and Gravel General Permit, your current permit coverage will terminate on March 31, 2021. If your permit is terminated and you discharge pollution to waters of the State, you are in violation of the federal Clean Water Act and/or Chapter 90.48 RCW.

OPTIONS TO REAPPLY

Reapply/Renew Online

The Washington State Department of Ecology (Ecology) uses SecureAccess Washington (SAW) for our applications to maintain security of your data. You can reapply for permit coverage using your existing SAW account. If you do not have a SAW account, you can:

Reapply by Mail

If you have an electronic reporting waiver, request a paper copy of the application form from your permit administrator. Please fill it out and mail your completed application to your regional Ecology office as soon as possible.

RENEWAL APPLICATION STATUS

To find information about a renewal application for your permit, visit <https://fortress.wa.gov/ecy/paris/PermitSearch.aspx> and search by entering the permit number or project name. Scroll down to see your application in a list of results. If your permit application says “Draft” (see “Status” column) then you have *not* completed and submitted your application. Any other “Status” designations indicate your application was received and is in the review process. We will notify you if any additional information is required.

CHANGES TO YOUR PERMIT COVERAGE
