Re: Application for Renewal of State Wastewater Discharge Permit

Permit No. ST0007380 has authorized the discharge of treated process wastewater from SeaCast Inc. facility to the City of Marysville Wastewater Treatment Plant. This permit is due to expire on June 30, 2021 and requires an application for renewal. The completed application is to be received at this office by April 30, 2021.

The Ecology permit manager for your facility is Maia Hoffman. She has marked those sections of the application which need to be filled out based upon our understanding of your facility. If there have been significant changes to the facility or to the character of the wastewater, you may need to fill in additional sections. Look over all of the questions to see if there are some that are applicable even if they have not been marked. Please submit any additional information that you feel may help Ecology determine the impact of your discharge upon the wastewater treatment plant.


