Dear Barney Conner:

Your application for a State Waste Discharge (SWD) permit renewal was received by this office on March 11, 2021 and accepted as complete on April 1, 2021.

Your application requested a change in the biochemical oxygen demand load limit for the discharge to the City of Mount Vernon (City) sewer system. The City has approved this change. Pursuant to RCW 90.48.200, if Ecology fails to take action on the application within 60 days after filing, the changes requested are authorized under a temporary permit. Therefore, changes requested in the permit application will be authorized beginning on May 10, 2021 until Ecology incorporates the changes in a new permit.

State law requires the circulation and publication of notices which describe the proposed issuance of SWD permits. This is intended to allow the public to be aware of and comment on such actions. Attached is a copy of the public notice that will be published in the Skagit Valley Herald on April 13 and 20, 2021. A similar notice will be mailed from this office to agencies, groups and individuals that have requested such notices for this geographic area.
