Permit No. WA0032166; Ice Floe LLC, dba Nichols Brothers Boat Builders (NBBB)

Dear Gavin Higgins:

Under the provisions of Chapter 90.48 RCW Water Pollution Control Laws as amended and the Federal Water Pollution Control Act (The Clean Water Act), the enclosed NPDES Permit No. WA0032166 is being issued to Ice Floe LLC dba Nichols Brothers Boat Builders located at 5400 S Cameron Road, Freeland, WA.

The permit authorizes the Permittee to discharge treated stormwater and rinse water from potable source and recycled stormwater into Holmes Harbor via the infiltration pond subject to the terms and conditions of the permit.

The Department of Ecology, in response to the passage of Initiative 97 in 1988, has adopted a regulation to recover costs associated with issuing and administering wastewater discharge permits (Chapter 173-224 WAC). The annual fee for both industrial and municipal/domestic discharges is computed according to the permit fee schedules contained in WAC 173-224-040. Ecology will notify permit holders of fee charges by mailed billing statements. Failure to pay the applicable permit fee may result in the suspension or revocation of the permit, and could result in the issuance of civil penalties or actions to enjoin the activity under the permit.

You have the right to appeal this permit within thirty (30) days upon receipt of this document. Complete details about appealing the permit are in Appendix B of the permit fact sheet. Pursuant to chapter 43.21B RCW, your appeal must be filed with the Pollution Control Hearings Board, and served on the Department of Ecology, within thirty (30) days of the date of your receipt of this document.

If you choose to appeal this action or decision, you must comply with the requirements of WAC 371-08-340.
