SECTION D: SUMMARY OF OBSERVATIONS AND FINDINGS																					
BACKGROUND																					
<p>Interstate Concrete & Asphalt dba Columbia ReadyMix Ellensburg Asph Plant located near Ellensburg, WA has permit coverage under Sand & Gravel General Permit No. WAG505041 with NAICS Codes 324121 and ECY001. This was an announced compliance inspection. The last inspection for this facility was on August 3, 2011. This site is currently active status. Electronic Discharge Monitoring Reports (DMRs) have been submitted on time for this facility.</p> <p>I arrived on site before Garrett. Billy Demoss, Plant Operator, and Ken Dragoo, Plant Manager, accompanied us on the inspection. The asphalt plant was not in operation during the inspection. Ken said they have not produced much asphalt this year. To the east of the asphalt plant, is a retention pond to contain stormwater, sampling point GSW2 (photo 1). North of the asphalt plant are the asphalt oil tanks and diesel fuel in secondary containment (photo 2). There is a spill kit located near the</p>																					

fuel tanks. There are some small stockpiles of recycled asphalt northeast of the tanks. Bed release agent is within secondary containment near a potable water tank (photo 3). Portable silos are at the south end of the site, they have not been used at this site yet (photo 4). Site conditions were dry.

Garrett sent me the Site Management Plans prior to the inspection and I reviewed them after the inspection. NAICS code 212321 is listed on the current site map for the stockpiles at the south end of the site and was listed on the previous permit. The current permit only lists 324121 and ECY001. I emailed Garrett to see if we need to add 212321 NAICS code to the current permit with a permit modification.

SUMMARY OF FINDINGS/COMMENTS

Based on the observations during the inspection, the following is to assist the facility's compliance with permit conditions.

The current site map and site conditions show NAICS code 212321 Sand & Gravel Mining, but it is not an activity listed on the current permit. The Permittee must notify the Ecology office to add, remove, or revise authorized activities listed in their coverage page (permit pg 8).


