Re: Reissuance of the Uplands Finfish Hatching and Rearing General Permit and Permit Coverage for Your Facilities

Dear Kelly Susewind:

The Washington State Department of Ecology (Ecology) is reissuing the Uplands Finfish Hatching and Rearing General Permit to be effective starting on October 1, 2021. You can find and review the new permit, fact sheet, permit forms, and other information at <https://ecology.wa.gov/Regulations-Permits/Permits-certifications/Upland-fin-fish-permit>. Please read the permit carefully. There are changes such as new monitoring requirements, plan submittals, and facility modification reporting just to mention a few but there are others. As a Permittee, you are legally obligated to comply with this permit's terms and conditions.

Ecology received your Notice of Intent applications for continued coverage under this general permit in the fall of 2020. Your facilities' permit coverage will be effective on October 1, 2021. Please review your permit requirements for all your facilities at the above link. This letter indicates the issuance of permit coverage for the following hatchery facilities:

Facility-Specific Coverage Page (see enclosure)

Once the permit is effective, as per permit requirements, you must have copies of this letter, the facility-specific coverage page, and the permit on site at each hatchery facility.

The facility-specific coverage page specifies the coverage being issued, which includes the maximum fish production. Please review all of the information on each facility-specific coverage page and the requirements and conditions of your coverage contained in the general permit.

Electronic Discharge Monitoring Reports

This permit continues to require you to submit electronic discharge monitoring reports. They are still submitted electronically using Ecology's secure online portal, WQWebDMR, as they were in the last permit. Permit Fees

Your permit annual fee is computed based on the permit fee schedules contained in Chapter 173-224 WAC. You will continue to receive fee invoices. Please contact Ligeia Heagy by email at Ligeia.Heagy@ecy.wa.gov or by phone at (360) 407-6425, with any fee related questions.

Appeal Process

You have a right to appeal coverage under the general permit to the Pollution Control Hearing Board (PCHB). Appeals must be filed within 30 days of the date of receipt of this letter. Any appeal is limited to the general permit's applicability or non-applicability to a specific discharger. The appeal process is governed by chapter 43.21B RCW and chapter 371-08 WAC. "Date of receipt" is defined in RCW 43.21B.001(2).
