Dear Bernie Ziemianek:

Ecology has completed the review of the Lighthouse Point Water Reclamation Facility's Discharge Monitoring Reports (DMRs) for 7/9/2021. The DMRs indicate your facility did not comply with the requirements established in your permit. The following parameters were not in compliance:
