- City of Anacortes Mixing Zone Study, dated January 2021 (prepared by Cosmopolitan Engineering)



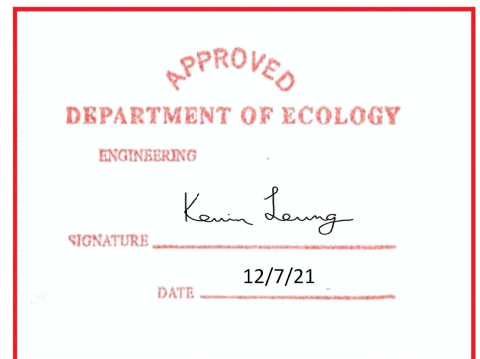

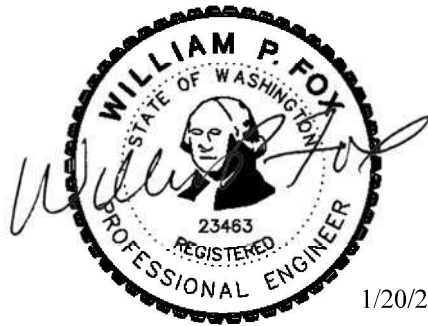
