1. General Information

This is an addendum to the permit and fact sheet for the State Waste Discharge Permit No. ST0045510, issued on December 2, 2019. The following change is made as notification of permit transfer to a new owner.

2. Modification to the Permit

The previous facility owner was National Foods based in Arlington, WA. The facility has been sold to a new owner, National Food NW LLC, located in Everett, WA. The facility has also been renamed National Food NW Hilltop Farm.

This modification updates contact information for the facility. It also updates Ecology Northwest Regional Office address and phone numbers that went into effect on May 17, 2021.

3. Justification

This minor modification is to update contact information to reflect the sale of the facility and transfer of permit coverage to a new entity.

4. Public Process

The proposed change in this modification is a minor modification. Changes do not involve increases in volume or changes in characteristics of discharge beyond those previously authorized that would require a public notice (WAC 173-216-090). Therefore, the changes are not required to be published for a 30-day public comment period.

Appendix A --Your Right to Appeal

To appeal you must do the following within 30 days of the date of receipt of this permit:

- File your appeal and a copy of this permit with the PCHB (see addresses below). Filing means actual receipt by the PCHB during regular business hours.
- Serve a copy of your appeal and this permit on Ecology in paper form - by mail or in person. (See addresses below.) E-mail is not accepted.

You must also comply with other applicable requirements in chapter 43.21B RCW and chapter 371-08 WAC.
