Dear Jerry McCaslin:

Thank you for submitting an application for a new state waste discharge (SWD) permit. The Department of Ecology (Ecology) acknowledges receiving the application on November 19, 2021. We accepted it as complete on November 24, 2021.

WAC 173-216-070 explains what satisfies the requirement for filing a permit application. RCW 90.48.200 states "In the event of failure of the Department to act upon an application within sixty days after it has been filed, the applicant shall be deemed to have a temporary permit. The permit shall authorize the applicant to discharge waste into waters of the State as requested in its application only until such time as the Department shall have taken action upon said application."

Therefore, your Temporary Permit will become effective on January 18, 2022 and will remain in effect until your SWD permit is issued or for up to five years, whichever occurs first. The temporary permit consists of the information submitted in the permit application. This authorization does not allow you to discharge pollutants not specified in your application and attachments, nor in quantities exceeding those specified in your application.

State law requires the circulation and publication of notices which describe the proposed issuance of SWD permits. This is intended to allow the public to be aware of and comment on such actions. Enclosed is a copy of the public notice that will be published in the Everett Herald on December 28, 2021 and January 4, 2022. A similar notice will be mailed from this office to agencies, groups and individuals that have requested such notices for this geographic area. Another public notice will be published when the draft permit has been prepared.
