The above facilities have re-applied for National Pollutant Discharge Elimination System (NPDES) permits in accordance with the provisions of Chapter 90.48 Revised Code of Washington (RCW), Chapter 173-220 Washington Administrative Code (WAC), and the Federal Clean Water Act.

**Kaiser Aluminum Washington** presently owns and operates an aluminum rolling mill and metal finishing plant at Trentwood, Washington that discharges treated wastewater to the Spokane River. The plant discharges an average flow of 6.2 million gallons per day of treated wastewater to the Spokane River from plant operations.

**The City of Spokane** owns and operates the Riverside Park Water Reclamation Facility that discharges treated wastewater to the Spokane River. The plant is designed to handle an maximum monthly average design flow of 68.1 million gallons per day (mgd), monthly average design flow of 43.2 mgd, and a maximum one day design flow of 96.4 mgd.

Following treatment, wastewater must meet the requirements of the Washington State Water Pollution Control Act and applicable regulations in order for a permit to be issued.

Following evaluation of the applications and other available information, Ecology has drafted these permits to allow the discharge of wastewater with the appropriate permit limits and conditions. A tentative determination has been made on the effluent limitations and special permit conditions that will prevent and control pollution. A final determination will not be made until all timely comments received in response to this notice have been evaluated.
