RE: Request for Compliance Schedule Extension; Entity Review of Draft Permit and Fact Sheet for National Pollutant Discharge Elimination System (NPDES) Permit WA0000825

Dear Kevin Rasler:

Ecology has reviewed your November 10, 2021 request to extend the compliance schedule for the final water quality based effluent limits (WQBELs) for Total Phosphorus (TP) and Carbonaceous Biochemical Oxygen Demand (CBOD<sub>5</sub>) established by the Spokane River and Lake Spokane Dissolved Oxygen Total Maximum Daily Load (DO TMDL). Ecology considered your request to extend the compliance schedule for an additional five years, but decided to put forward a shorter timeline. Ecology will propose extending the compliance schedule for these parameters for the first two compliance seasons (2022 and 2023) in order that these limits are met as soon as possible.

Enclosed is the preliminary draft copy of Ecology's proposed permit and fact sheet that includes the compliance schedule extension. Please take this opportunity to review the draft documents in entirety for factual mistakes or errors and comment on any mistakes you or your staff find. Ecology will make the appropriate corrections in the draft permit and fact sheet and place a public notice in a local newspaper. An official draft copy of the permit and fact sheet will be mailed to you along with a copy of the public notice. There will be a 45-day comment period from the date of publication. At that time, Inland Empire Paper Company will have the opportunity to submit comments on requirements and conditions in the permit.
